C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 37.79 acre tract that was determined to contain 14.67 acres of jurisdictional freshwater wetlands. These wetlands continue off site and abut Mary Branch, a pRPW, that flows into three more tributaries before discharging into the Waccamaw River, a TNW. Limits of jurisdiction were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. Uplands lacked indicators of hydrology and/or hydric soils during a site visit conducted on 11/9/18 .
