**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form assesses a 3.26 acre tract that consists entirely of uplands. The site consists of non-hydric soils which exhibited greater than 70% uncoated sand grains. Based on documentation from previous site visits and data sheets submitted by the agent, indicators of hydrology are also absent throughout the site. There are two non-jurisdictional ditches along the western and southern property boundaries that were determined to be man-made and excavated entirely out of uplands and drain only uplands. Two previous Jurisdictional Determinations for this property were issued on July 30, 2008 and August 8, 2014, a site visit was conducted in association with the 2008 JD and the site was determined to be void of wetlands or other waters of the United States.
