B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: The topo map shows the upper end of a topographic draw on the property. Consultant photos show a linear feature within the topographic draw. A low area lies next to the channel, but the data point and photos submitted by the consultant show that the low-lying area is not wetland. It appears this site has been highly modified and disturbed; furthermore. This office agrees with the conclusions of the submitted information documented on this form. The project area consists entirely of dry lands.
