**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The site assessed on this form (TMS# 7050201000000) is approximately 6 acres in size and consists entirely of uplands. The majority of the site is mapped Lakeland soil which is non-hydric. The entire site is mapped uplands (U11) on the National Wetlands Inventory map. LiDAR also depicts an upland signature throughout the entire site. The topographic map depicts a solid blue line (i.e. tributary) along the northern property boundary. However, after researching the best available information including aerial photography and Google Earth Street View, the Corps has determined that the blue line is an upland excavated drainage ditch constructed for the purposes of stormwater management. Therefore, the Corps has determined that the ditch is non-jurisdictional.
