However, based on review of offsite resource information, the onsite Wetland B-1 is part of a closed polygon wetland that extend offsite. Additionally, based on a review of the offsite resource information, the wetland that is not contiguous or directly abutting an (a)(1)-(a)(3) water. In addition, this wetland does not meet any of the other (a)(4) criteria for adjacency and thus is an excluded water pursuant to (b)(1).
