Explain: **The project review area includes three (3) wetlands, Wetland 7 (0.28 ac), Wetland 8 (0.30 ac) and Wetland 9 (0.09 ac), that were determined to be isolated, non-jurisdictional wetlands. Based on a review of LiDAR, aerial photographs, NWI maps and soil survey information, Wetlands 7 and 8 continue offsite to the north and west. Based on a review of the resource information it appears that Wetland 7 and 8, including their offsite portions of the wetlands, are surrounded by uplands and sit lower in the landscape than surrounding uplands. Additionally, a review**

of LiDAR shows that there are no ditches or swales flowing out of the wetlands. Wetland 9 also continues offsite onto an adjacent property that was subject to a wetland delineation and Nationwide Permit Default Letter, SAC-2019-00542. The wetland delineation shows that the entire Wetland 9, both onsite and offsite portions, is surrounded by uplands. A review of resource information shows that the wetland sits lower in the landscape than the surrounding wetlands and shows that there are no ditches or swales flowing out of the wetland. Wetlands 7, 8 and 9 have no apparent shallow subsurface hydrologic connection, and no physical, chemical or biological connection, from the wetlands to waters of the US. In addition, the wetlands have no apparent ecological interconnection to waters of the US. Therefore, Wetlands 7, 8 and 9 are non-jurisdictional and not subject to regulation under Section 404 of the CWA or Section 10 of the RHA.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW.
