MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023),¹ SAC-2024-0842, (MFR# 1 of 1)²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

The review area encompasses the entirety of PIN 249-00-00-0030 and large portions of adjacent tracts (PINs 249-00-00-0029 and 249-00-00-0028) to the west. A series of upland excavated ditches and ponds are onsite with each ditch terminating at the accompanying pond. The ponds and accompanying ditches are listed in series within Table 1(a) above. Pond 4 is separated from adjacent pond 2 by a small earthen dike. An excavated ditch parallels the property line dividing PIN 249-00-00-0030 from 249-00-00-0029. The review area is comprised almost entirely agricultural and pastoral lands with partially cleared woodlands existing along the eastern boundary of PIN 249-00-00-0030. The site is devoid of hydric soils with agent submitted data corroborating soil types deemed upland in adjacent SAC-2019-01355, continuing onto the current area of review.
