be non-jurisdictional. The forested freshwater wetlands located within the project area were viewed during the site visit and determined to be completely surrounded by non-hydric soils. The two wetlands are completely contained within the project area. No linear features were observed within or near the wetland boundaries. No surface or shallow subsurface connection to any waters of the US were viewed during the site visit.

All water located within or draining towards the wetlands had no discernable or traceable outfall or connection to any waters of the US. Chemically, the wetlands do not affect any waters of the US in the absorption/treatment of nutrients, runoff, or pollutants. Physically, the topographic location of the wetlands and their relation to other waters of the US are such that water in these wetlands are retained and either evaporates or eventually percolates through the soil to groundwater only, at an unknown depth, providing little if any stormwater attenuation. Biologically, these wetlands are not essential in providing organic carbon in the form of their collective primary productivity to downstream waters. Because of the lack of a discernable outfall, topography grades and because there are no biological, chemical, or physical connection to any jurisdictional aquatic resources and no apparent connection with interstate or foreign commerce, Wetland B and Wetland C were determined to be isolated, non-jurisdictional wetlands.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Physically, the topographic location of the wetlands and their relation to other waters of the US are such that water in these wetlands are retained and either evaporates or eventually percolates through the soil to groundwater only, at an unknown depth, providing little if any stormwater attenuation. Biologically, these wetlands are not essential in providing organic carbon in the form of their collective primary productivity to downstream waters. Because of the lack of a discernable outfall, topography grades and because there are no biological, chemical, or physical connection to any jurisdictional aquatic resources and no apparent connection with interstate or foreign commerce, Wetland B and Wetland C were determined to be isolated, non-jurisdictional wetlands.
