**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Based on a review of all available desk top resources including but not limited to a delineation report submitted by the agent, aerial photographs, and a previous jurisdictional determination, the Project Area has been determined to contain 37.92 acres of partially developed uplands. In addition, the project area contains 4.58 acres (depicted as “Protected Area” on the associated plat) that was not reviewed under this determination due to the fact that it was previously placed under Restrictive Covenants under Department of the Army permit #2000-1P-466. The 42 acre parcel contains 4.58 acres protected by Restrictive Covenants that was not reviewed. Therefore, this Jurisdictional Determination is for the remaining 37.92 acres located within the parcel. Department of the Army Permit #2000-1P-466 has been modified to reflect the reduction in “Protected Areas” where alternate mitigation has been provided. .
