of the property. This low area is mapped as palustrine wetlands on the NWI maps and Rutlege soil (hydric) on the soil survey. However, the consultant's data sheets note that there is no hydrology indicators observed in this area and greater than 30% uncoated sand grains were observed in the upper 6" of the soil profile. Therefore, the Corps has determined this area to be uplands. In addition, a ditch traverses the low gradient area on the property. This was observed by the consultant and lacked an OHWM and other flow characteristics to be determined a tributary. This ditch is a man-made drainage feature designed to carry stormwater off the property. Furthermore, the ditch is not depicted as a blue line on topo maps.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW.
