Dear Mr. Nichols:

This is in response to your letter of December 29, 2015, requesting a wetland determination, on behalf of South Carolina State Ports Authority, for a 5.59-acre tract located at the Palmetto Railways Cosgrove Yard (0.3 mile east of the intersection of Remount Road and North Rhett Avenue), in North Charleston, Charleston County, South Carolina. The project area is depicted on the survey plat you submitted which was prepared by Thomas & Hutton, dated January 26, 2016, and entitled "Wetland Survey Portions of S.C. State Ports Authority, Kapstone Charleston Kraft, LLC & CSX 60' R/W".

This plat depicts surveyed "Critical Area" boundaries as established by your office and/or the South Carolina Department of Health and Environmental Control, Office of Ocean and Coastal Resource Management (OCRM). You have requested that this office verify the accuracy of this mapping as a true representation of areas within the regulatory authority of this office. The property in question is a 5.59-acre tract owned by S.C. State Ports Authority, and contains 1.17 acres of jurisdictional waters of the United States, which includes wetlands. These salt marsh wetlands and open-water tidal areas are identified on the referenced plat as "TNW/OCRM Critical Wetland Area". There are no federally defined freshwater areas which are subject to the jurisdiction of this office on the property in question.

Based on an on-site inspection and a review of aerial photography and soil survey information, it has been determined that the surveyed jurisdictional boundaries shown on the referenced plat are an accurate representation of jurisdictional areas within our regulatory authority. This office should be contacted prior to performing any work in these areas.

If a permit application is forthcoming as a result of this delineation, a copy of this letter, as well as the verified survey plat, should be submitted as part of the application. Otherwise, a delay could occur in confirming that a delineation was performed for the permit project area.

Please be advised that this determination is valid for five (5) years from the date of this letter unless new information warrants revision of the delineation before the expiration date. All actions concerning this determination must be complete within this time frame, or an additional delineation must be conducted. This **approved** jurisdictional determination is an appealable action under the Corps of Engineers administrative appeal procedures defined at 33 CFR 331. The administrative appeal options, process and appeals request form is attached for your convenience and use.

This delineation/determination has been conducted to identify the limits of U. S. Army Corps of Engineers (COE) Clean Water Act jurisdiction for the particular site identified in this request. This delineation/determination may not be valid for the wetland conservation provisions of the Food Security Act of 1985. If you or your tenant are USDA program participants, or anticipate participation in USDA programs, you should request a certified wetland determination from the local office of the Natural Resources Conservation Service, prior to starting work.

Prior to performing any work, you should contact the South Carolina Department of Health and Environmental Control, Office of Ocean and Coastal Resource Management (OCRM). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project areas includes 1.17 acres of tidal marsh TNW that is jurisdictional on the basis of its tidal character. There is a ditch which measures 1,656 feet in length within the project area. The ditch was excavated from uplands and drains an upland constructed stormwater treatment pond outside the project limits. This ditch and the

stormwater treatment pond from which it drains receive runoff input exclusively from uplands. On this basis, the ditch does not meet the definition of Waters of the U.S. and is not within the jurisdiction of Section 404 of the Clean Water Act.
