This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Based on a review of the aerials, topographic map, soil survey, NWIs and information submitted by the agent, the site was determined to be void of aquatic resources. The aerials depict this site as cleared agricultural fields. A small forested area is located near the western property boundary; however, a data point submitted by the agent for this location shows that this area does not contain hydric soils or indicators of hydrology. The topographic map depicts this site as cleared uplands, and the soil survey maps this site as Fuquay and Dothan, which are not hydric soils. The NWIs map this site as upland agricultural fields (U21). Therefore, this site was determined to consist entirely of uplands.
