southwest off of the project site. A data point submitted by the agent in this area determined that this area does not contain hydric soils or indicators of hydrology. According to the aerials, this entire site has been an active agricultural field since prior to 1994. The majority of the site has been in agricultural production since prior to 1970, according to the Soil Survey for Florence and Sumter Counties. The remainder of the site is mapped uplands (U21) on the NWIs and Goldsboro, a partially hydric soil, on the soil survey. The aerials depict this site as an active ag. field, and the topographic map depicts this site as cleared and forested uplands. The linear feature was determined to be a man-made, non-jurisdictional ditch based on a review of the aerials, topographic map, and information submitted by the agent. Therefore, this site was determined to consist entirely of uplands..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
