isolated and non-jurisdictional. This wetland was a depressional wetland, surrounded by uplands, and had no ditches, swales, or other linear features coming out of it that would potentially provide a surface hydrologic connection from the wetland to other waters of the U.S. In addition, there were no visible signs of discrete flow through the uplands from the isolated wetlands to waters of the U.S. There was no apparent subsurface hydrologic connection, and no apparent physical, chemical, or biological connection to waters of the U.S. The wetland also had no apparent ecological interconnection to waters of the U.S. For these reasons, the wetland on site was determined to be isolated and non-jurisdictional and therefore not regulated by Section 404 of the Clean Water Act.



C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The potentially jurisdictional wetland located within the project area (1.47 acres) was determined to be isolated and non-jurisdictional. This wetland was a depressional wetland, surrounded by uplands, and had no ditches, swales, or other linear features coming out of it that would potentially provide a surface hydrologic connection from the wetland to other waters of the U.S. In addition, there were no visible signs of discrete flow through the uplands from

the isolated wetlands to waters of the U.S. There was no apparent subsurface hydrologic connection, and no apparent physical, chemical, or biological connection to waters of the U.S. The wetland also had no apparent ecological interconnection to waters of the U.S. For these reasons, the wetland on site was determined to be isolated and non-jurisdictional and therefore not regulated by Section 404 of the Clean Water Act.

The previous JD for this site (SAC-2006-1361-IJ), issued on June 9, 2006 also determined the wetlands to be isolated, and therefore non-jurisdictional.

Two site visits were performed on September 23, 2015 and again on December 17, 2015.
