Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There is a ditch that runs along the parcel boundary that appears to have been dug to provide drainage for the access road on the adjacent parcel. According to Google Earth aerial imagery, the ditch was dug between September, 2010 and June, 2011. In the 2010 aerial image the ditch was not present and the parcel consisted of two homes and a maintained lawn. In the 2011 aerial image the homes had been removed, a roadway cleared on the adjacent parcel along the parcel boundary, and the ditch had been dug. According to the wetland delineation submittal from the consultant, the parcel does not contain hydric soils or wetland hydrology. In addition, the NRCS Web Soil Survey depicts the project area to be mapped as non-hydric soils. Based on the above information, it has been determined that the parcel consists wholly of uplands and the ditch was excavated out of uplands for the purpose of draining uplands. Therefore the parcel and ditch are non-jurisdictional and not subject to regulation under Section 404 of the Clean Water Act.
