determined to be isolated (non-jurisdictional). These three wetlands were previously determined to be jurisdictional under SAC# 2009-01328-4JE (Letter dated September 16, 2010) via a man-made, non-jurisdictional ditch. However, since the issuance of our Jurisdictional Determination letter dated September 16, 2010, the landowner has filled in the non-jurisdictional ditch causing the three wetlands to be isolated. After reviewing, aerial photographs, topo maps, soil survey information, and NWI maps, it was determined that there has been no development on the property or any landscape changes that could potentially create a hydrologic connection from the wetlands to any other waters of the U.S. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of a chemical or biological connection to other waters of the US, these wetlands were determined to be isolated and non-jurisdictional.

In addition, seven (7) other wetlands on the property (depicted in yellow on the attached map) have been filled in accordance with the previous isolated determination dated September 16, 2017.



# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Because of the lack of discernable outfall, topography grades, and lack of evidence of a chemical or biological connection to other waters of the US, these wetlands were determined to be isolated and non-jurisdictional. In addition, seven (7) other wetlands on the property (depicted in yellow on the attached map) have been filled in accordance with the previous isolated determination dated September 16, 2017.
