**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The site assessed on this form is a 6.24 acre tract consisting of 186 linear feet of tributary. It appears that it was originally a natural meandering tributary located to the west of its current location. The tributary was moved and straightened, possibly for drainage purposes. The tributary exhibited a distinct line along the bank (i.e. OHWM) and a firm sandy bottom with prominent sinuosity along the stream bed. Sediment sorting, shelving, wrack lines, and flowing water were also observed during the site visit. All these characteristics are indicative of perennial flow in this landscape. In addition, a ditch along the northern property boundary and a pond along the eastern property boundary were both determined to be non-jurisdictional. The ditch was excavated out of uplands and drains only uplands and exhibited no characteristics of flow. The ditch continues into the onsite pond. The pond was also determined to be excavated entirely out of uplands.
