- ☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The project area contains 2 non-jurisdictional ditches. After review of the agent's provided site photos the ditches were determined to be nothing more than upland excavated farm ditches used to drain a former upland agricultural field. The ditches were determined to be upland excavated and drain only uplands and therefore not considered tributaries. Review of the Horry County NWI maps revealed that potential wetlands may exist within the project area. The project area is partially mapped as forested wetlands (PFO4/1B) on the Horry County NWI map. However, the submitted wetland data does not reflect wetlands within the project area. The project area, according to the data sheet submitted by S&ME, lacks all three parameters which define a wetland as outlined in the Corps' 1987 Wetland Delineation manual.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
