This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD: The off-site tributary named Sammy Swamp was determined to have perennial flow based on a review of the topographic map, which depicts this named tributary as a solid blue line. The aeriels depict this tributary as a shaded linear feature. The soil survey maps this tributary as Osier, a hydric soil, and the NWIs map this tributary as a palustrine forested wetland (PFO1C). Sammy Swamp continues east where it flows into the Pocatigo River, a pRPW. The Pocatigo River flows southeast into the Black River, a TNW**

**Jurisdictional Impoundment 2 was determined to be jurisdictional after reviewing the aeriels, soil survey, and NWIs. The aeriels depict this impoundment as the eastern portion of Jurisdictional Wetland 7 which is open water. The soil survey maps this impoundment, as well as the two jurisdictional wetlands on site, as Rutledge, a hydric soil. The NWIs map this impoundment as PUBHh. This impoundment was determined to have been created out of Jurisdictional Wetland 7 and connects to Jurisdictional Wetland 8 via a culvert.**

**Jurisdictional Wetlands 7 & 8 were determined to directly abut the off-site tributary named Sammy Swamp based on a review of the aeriels, topographic map, soil survey, and NWIs. The aeriels and topographic map depict these wetlands as forested wetlands that are a small portion of a large wetland bay that continues southeast off of the property. The NWIs map these two wetlands as palustrine forested wetlands (PFO1C and PFO4/1B). The soil survey maps these two wetlands as Rutledge, a hydric soil..**
