C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 0.47 acres of wetlands on site are part of Bob Dam Swamp. Hydrologic flow runs off site through a culvert under Interstate 95 and continues east until Bob Dam Swamp runs into New River. Bob Dam Swamp surrounds New River, a Perennial RPW. New River becomes a TNW tidal tributary downstream of the project site and then flows directly into the ocean. Therefore, the 0.47 acres of wetlands on site are waters of the U.S. regulated under Section 404 of the Clean Water Act.
