- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Four non-jurisdictional stormwater drainage ditches are located on-site. Ditch 1 bisects the project area at an angle running west to east. Ditches 2 and 3 are perpendicular to ditch 1 and drain into it. Ditch 4 runs south to north along the western project boundary. These features were examined during a site visit conducted on January 11, 2017 and were determined to have been excavated out of uplands and to drain only uplands.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 36.17 acre tract that was determined to consist entirely of uplands. During a site visit conducted on January 11, 2017 it was observed that the site consisted of a regularly mowed and maintained pine flat and that soils on site did not meet any hydric soils criteria outlined in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. Additionally, the site lacked indicators of hydrology during a period of normal to above average rainfall.

Four non-jurisdictional stormwater drainage ditches are located on-site. Ditch 1 bisects the project area at an angle running west to east. Ditches 2 and 3 are perpendicular to ditch 1 and drain into it. Ditch 4 runs south to north along the western project boundary. These features were examined during a site visit conducted on January 11, 2017 and determined to have been excavated out of uplands and to drain only uplands.

Two upland excavated storm water ponds are located near the southeast corner of the project area. These features were determined to have been excavated out of uplands for the purpose of stormwater retention and are determined to be non-jurisdictional. .
