

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This tributary flows north into an unnamed tributary of Big Swamp, which flows into Big Swamp. Big Swamp, a perennial RPW, continues south where it flows into the Lynches River.

The on-site wetland was determined to be a portion of a larger wetland system that continues west and north off site. The aerials and topographic map depict this wetland as directly abutting the on-site perennial RPW. The soil survey maps this wetland as Wehadkee & Johnston, a hydric soil. The NWIs map this wetland as palustrine forested (PFO1Bd)

Several potentially jurisdictional linear features were observed within the project area. These features were determined to be manmade and excavated out of upland agricultural fields. Therefore, these features were determined to be non-jurisdictional ditches.
