**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

characteristics of having flowing water at least 90% of the year under normal climatic conditions. The stream geomorphic indicators of perennial flow was a channel within the bed and banks which had a firm sandy bottom clear of vegetation and debris, the presence of a OHWM, and scouring on the banks. In addition, the stream contained small aquatic fauna such as minnows that indicate the continuing presence of fresh flowing water. An even distribution of substrates were observed on the channel bottom. Furthermore, a review of aerial photos, topographic maps, Horry County Soil Survey, and Horry County Drainage Canal Study concurred with the evidence that the tributary is an RPW with perennial flow. Aerial photos depict a signature of a defined channel, topographic maps depict a symbol which represents a tributary with perennial flow, Horry County Drainage Canal Study depicts a main drainage canal (M-34) which represents a tributary with perennial flow, and Horry County Soil Survey depicts a symbol that represents a tributary with intermittent flow.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 12.62 acre parcel located south of the City of Conway. The area was free of wetlands, lacking the appropriate hydric soils and hydrology to be considered a wetland. The NWI maps show the symbol for wetlands, however the appropriate parameters were not met.

In addition, the stream contained small aquatic fauna such as minnows that indicate the continuing presence of fresh flowing water. An even distribution of substrates were observed on the channel bottom. Furthermore, a review of aerial photos, topographic maps, Horry County Soil Survey, and Horry County Drainage Canal Study concurred with the evidence that the tributary is an RPW with perennial flow. Aerial photos depict a signature of a defined channel, topographic maps depict a symbol which represents a tributary with perennial flow, Horry County Drainage Canal Study depicts a main drainage canal (M-34) which represents a tributary with perennial flow, and Horry County Soil Survey depicts a symbol that represents a tributary with intermittent flow.

The site is assessed on a single basis form .
