The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Project area is comprised of 130.672 acres of uplands. Portions of the project area have been developed under prior Department of the Army authorizations as well as previous jurisdictional determinations. The project area did contain potential wetland areas that were assessed. However, these areas lacked all three parameters which define a wetland as outlined in the 1987 Wetland Delineation Manual and/or Regional Supplement. These areas lacked hydrology and indicators of hydrology. Finally, the project area contains two upland excavated man-made non-jurisdictional ditches. Note: the project area contains 6.60 acres protected area. These 6.60 acres depicted as "Preservation Area" on the above referenced plat were not reviewed and therefore not included in this determination.
