Wetland Delineation Manual and applicable regional supplement. A field inspection was completed on December 6, 2018, to verify the boundary of the wetlands onsite. The 22.523 acres of wetlands are part of a large wetlands system. The areas outside the site boundaries were not accessible to verify the presence or absence of waters. Therefore, remote resource tools were utilized to approximate the boundary of the large wetlands system that extends outside the subject site boundary. Based on utilizing remote resource tools to include USGS Topographic map, LIDAR, infrared photography, and Soil Survey map the larger wetlands system boundary is approximately the boundary of the All Hydric USDA Soil Survey line encompassing the majority of the 22.523 acre wetlands delineated on-site. This All Hydric soil is surrounded by Partially Hydric soil separating the larger wetlands system from Dawson Branch to the south (approximately 1,320'), Cypress Swamp to the west (approximately 2,112'), and Felder Branch to the north (approximately 2,112'). Therefore, the larger wetlands system appears to have no apparent physical, chemical, or biological connection to waters of the U.S., and has no apparent surface or shallow subsurface hydrologic connections to waters of the U.S. The larger wetlands system also has no connection to interstate or foreign commerce. The 22.523 acres of wetlands on-site were previously determined to be isolated in AJD SAC-2008-02065, and wetlands to the south of the site that are a part of the larger wetlands system was determined to be isolated in AJD SAC-2008-01476.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
