criteria of a wetland since there is no vegetation within the borrow pits. In addition, the borrow pits are surrounded by upland soils with a high chroma. Therefore, it appears the borrow pits were excavated in the uplands. As stated in the Preamble to the November 13, 1986, Regulations found on page 41217 (Federal Register vol. 51 No. 219) "waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United States" are generally not considered waters of the U.S. Therefore, these borrow pits were determined to be non-jurisdictional aquatic resources.

SECTION III: CWA ANALYSIS

Freshwater Wetland A is located next to tidal James Island Creek and adjacent to Tidal Wetland B. There are some uplands located between Freshwater Wetland A and Tidal Wetland B; however, a swale was observed in these uplands during the site visit. The swale drains from Freshwater Wetland A into Tidal Wetland B, which then flows into James Island Creek. The swale can also be seen on LIDAR. Therefore, Freshwater Wetland A is adjacent to a TNW and has a hydrological connection to a TNW.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
