C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project is comprised of 42.59 acres of which approximately 2.65 acres have been identified as freshwater wetlands. 0.4 acres has been determined to be isolated, non-jurisdictional. The remaining 2.55 acres are jurisdictional and documented as such on basis form 2. The forested freshwater 0.4 wetland located within the project area has been determined to be to be surrounded by non-hydric soils and no surface or shallow subsurface connection to any waters of the U.S

(WOUS) was evident. This wetland exhibited hydric soils, hydrophytic vegetation, and sufficient indicators of hydrology to satisfy the criteria set forth in the 1987 Wetland Delineation Manual. However, all water located within this wetland has no discernible or traceable outfall or connection to any WOUS. Because of the lack of discernible outfall, topography grades, and lack of evidence of chemical, physical or biological connection, this wetland system has been determined to be isolated, non-jurisdictional. In addition, the project area contains one upland excavated pond determined not to be an impoundment of waters of the U.S. as well as an upland excavated ditch.
