### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus See 51 Fed. Reg. 41206, 41217 (Nov. 13, 1986)..**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

**This form addresses a 1.67 acre tract that was determined not to contain any waters of the U.S.. The USGS topographic survey information located within Myrtle Beach quad depicts the project area as uplands that do not contain any symbols that would typically represent a WOUS. The NWIs depict the project area as being void of potential aquatic resources. Although, soil survey information depicts hydric soils on site, the agent's data forms indicate an absence of hydric soils indicators. Aerial photographs depict a developed upland lot with scatter pine trees near the northern property boundary and a building onsite.**

**One upland excavated linear conveyance is located along the western property boundary. This feature was determined to have been excavated out of uplands and to drain only uplands. It is not depicted on NHD, USGS topographic maps (as a blue line feature or low lying drainage area), or on NWIs. It appears to be man-made and located wholly in uplands. This feature is determined to be an upland excavated stormwater drainage ditch and therefore non-jurisdictional. See 51 Fed. Reg. 41206, 41217 (Nov. 13, 1986).**
