Explain: Based on a review of the aerials, topographic map, NWIs, and information submitted by the agent, the 10.93-acre site was determined to consist of uplands. Although the soil survey maps the majority of this site as Ogeechee, which is a hydric soil, the remainder of the site is mapped Yauhannah, which is not a hydric soil. The NWIs map this site as uplands, and the aerials and topographic map do not depict any potential waters on site. Information submitted by the agent found that

although hydric soils and hydrophytic vegetation were present on site, no indicators of hydrology were found. Therefore, this site does not contain any waters of the US and consists of uplands.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Based on a review of the aerials, topographic map, NWIs, and information submitted by the agent, the 10.93-acre site was determined to consist of uplands. Although the soil survey maps the majority of this site as Ogeechee, which is a hydric soil, the remainder of the site is mapped Yauhannah, which is not a hydric soil. The NWIs map this site as

uplands, and the aerials and topographic map do not depict any potential waters on site. Information submitted by the agent found that although hydric soils and hydrophytic vegetation were present on site, no indicators of hydrology were found. Therefore, this site does not contain any waters of the US and consists of uplands.
