ponds, and 2) non-jurisdictional isolated wetlands. Eight non-jurisdictional stormwater ponds totaling 22.403 acres are located in the review area. These ponds were excavated entirely from uplands for the purpose of retaining and treating stormwater from the site. The ponds consist of open water, do not meet the three parameters of a wetland, and were constructed to meet the requirements of CQA Section 402. For these reasons, these ponds were determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA. Non-jurisdictional isolated wetlands include three wetlands identified as Area J (0.304 acre), Area K (0.111 acre), and Area DD (0.377 acre). These wetlands each are comprised of geographically distinct polygonal boundaries which are not contiguously abutting other jurisdictional waters, and exhibit no other adjacency factors that would support bordering or neighboring adjacency. Most conspicuously, these three wetlands have no type of hydrologic connectivity to jurisdictional waters. On this basis, the 0.792 acre of these three freshwater wetlands are isolated and non-jurisdictional.

Summarize rationale supporting conclusion that wetland is “adjacent”: Twelve wetlands on the site, totaling 32.772 acres, are adjacent to the tidal waters of the TNW Cooper River. These wetlands are adjacent due to being contiguous and/or bordering the Cooper River. In each case, the wetlands either exhibit boundaries that directly abut the Cooper River tidal marsh, or they are hydrologically connected via culverts and reasonably close proximity.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

For these reasons, these ponds were determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA. Non-jurisdictional isolated wetlands include three wetlands identified as Area J (0.304 acre), Area K (0.111 acre), and Area DD (0.377 acre). These wetlands each are comprised of geographically distinct polygonal boundaries which are not contiguously abutting other jurisdictional waters, and exhibit no other adjacency factors that would support bordering or neighboring adjacency. Most conspicuously, these three wetlands have no type of hydrologic connectivity to jurisdictional waters. On this basis, the 0.792 acre of these three freshwater wetlands are isolated and non-jurisdictional.
