jurisdictional. The wetlands, E, F, O, I, J, XL, WB, and NW, are located at higher elevations than the other wetlands and waters located onsite, are surrounded by uplands and have no ditches or swales coming out of them. No evidence of discrete surface hydrologic connections from these wetlands through the uplands to other wetlands or waters were observed. In addition, there was no apparent shallow subsurface hydrologic flow and no apparent physical, chemical, or biological connection from the wetlands to the waters of the U.S. These wetlands also have no apparent ecological interconnection to waters of the U.S. For these reasons, Wetlands E, F, O, I, J, XL, WB, and NW, totaling 2.046 acres, were determined to be isolated, not jurisdictional and not regulated by Section 404 of the CWA.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The tributary's connectivity underground and offsite is evident as the tributary is represented as a blue line (perennial) stream channel on the USGS topographic map.
