- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Several open water ponds exist within the footprint of the existing golf course. However, other than the features shown on the survey plat, these features were determined to be dug out of and draining wholly uplands. Additionally, there are several ditches within the property which provide a linear connection from the ponds to downstream waters. These features were also determined to be excavated wholly in uplands and do not contain evidence of relatively permanent flow. Therefore, these features were determined to be non-jurisdictional under Section 404 of the CWA and Section 10 of the RHA.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. Additionally, 538 linear feet of perennial tributary were also determine to be jurisdictional under section 404 of the CWA.
