A linear feature is located along the northern property boundary, which was determined to be a non-jurisdictional ditch. This feature is depicted as a straight blue line on the topographic map and as a linear feature located adjacent to an agricultural field on the aerials. On the NWIs, this feature is mapped R5UBH, and on the soil survey, this feature is mapped predominately as Persanti fine sandy loam, which is a non-hydric soil. This feature was determined to be a man-made agricultural ditch located at the property boundary, and, therefore,

is non-jurisdictional. A pond is also located within the project boundary. This pond is depicted on the topo map and aerials as being located within agricultural fields. The pond is mapped Faceville, a non-hydric soil, on the soil survey, and as PUBHx on the NWIs. This pond was determined to be a man-made feature and is a non-jurisdictional pond.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

A linear feature is located along the northern property boundary, which was determined to be a non-jurisdictional ditch. This feature is depicted as a straight blue line on the topographic map and as a linear feature located adjacent to an agricultural field on the aeriels. On the NWIs, this feature is mapped



R5UBH, and on the soil survey, this feature is mapped predominately as Persanti fine sandy loam, which is a non-hydric soil. This feature was determined to be a man-made agricultural ditch located at the property boundary, and, therefore, is non-jurisdictional. A pond is also located within the project boundary. This pond is depicted on the topo map and aerials as being located within agricultural fields. The pond is mapped Faceville, a non-hydric soil, on the soil survey, and as PUBHx on the NWIs. This pond was determined to be a man-made feature and is a non-jurisdictional pond. The remainder of the site was determined to consist of uplands, and no waters of the US are present.
