Explain: **There are two isolated wetlands located on site; Wetland A is 1.15 acres and is located in the northern portion of the site, Wetland B is 0.65 acre and is located in the southern portion of the site. These two wetlands are surrounded by uplands and do not have any observable connections to waters of the U.S and no noticeable nexus to interstate or intrastate commerce. For these reasons, the two wetlands located on this site were determined to be non-jurisdictional and not subject to Section 404 of the CWA or Section 10 of the RHA.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site contains two non-jurisdictional isolated wetlands. The wetlands are surrounded by uplands and do not have connection to waters of the U.S or interstate and intrastate commerce.
