Explain: **One potentially jurisdictional wetland is located within the project area. The depressional wetland, labeled Non-jurisdictional Wetland A, is depicted as forested on the aeriels and as uplands on the topographic map. The soil survey maps this area as Pantego Fine Sandy Loam, a hydric soil, and the NWIs map this wetland as PSS3/FO4Bd. This wetland intersects the property from the southwest to the northeast and continues off site; however, based on a**

review of the NWIs and topographic map, this depressional wetland terminates immediately northeast of the property, and the southwestern portion of the offsite wetland also ends immediately southwest of the project site. No linear features or other potential waters are present within or adjacent to the boundary of this wetland according to the topographic map, aerials, or NWIs. Based on information submitted by the agent, this non-jurisdictional wetland was determined to be surrounded by non-hydric soils and have no connection to any other potential WOUS. Therefore, Non-jurisdictional Wetland A was determined to be isolated and non-jurisdictional.

This depressional wetland exhibited hydric soils and indicators of hydrology, which satisfies the criteria set forth in the 1987 Wetland Delineation Manual and the Atlantic and Gulf Coastal Plain Regional Supplement. This wetland is forested with hydrophytic vegetation present. All water located within or draining toward this wetland has no discernible or traceable outfall or connection to any WOUS. Additionally, this wetland was found to be completely surrounded by uplands, which further disrupts any possible connection to any WOUS. Because of the lack of discernible outfall, topography grades and lack of evidence of chemical, physical, or biological connection, this wetland was determined to be isolated, non-jurisdictional.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** One potentially jurisdictional wetland is located within the project area. The depressional wetland, labeled Non-jurisdictional Wetland A, is depicted as forested on the aerials and as uplands on the topographic map. The soil survey maps this area as Pantego Fine Sandy Loam, a hydric soil, and the NWIs map this wetland as PSS3/FO4Bd. This wetland intersects the property from the southwest to the northeast and continues off site; however, based on a review of the NWIs and topographic



map, this depressional wetland terminates immediately northeast of the property, and the southwestern portion of the offsite wetland also ends immediately southwest of the project site. No linear features or other potential waters are present within or adjacent to the boundary of this wetland according to the topographic map, aerials, or NWIs. Based on information submitted by the agent, this non-jurisdictional wetland was determined to be surrounded by non-hydric soils and have no connection to any other potential WOUS. Therefore, Non-jurisdictional Wetland A was determined to be isolated and non-jurisdictional.
