C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Area in review (project area 111.83 acres) contained no wetlands or other Waters of the U.S. (WOUS). This site is comprised primarily of Leon and Brookman soils (hydric), Horry County NWI data depict the site primarily as U42 (uplands) with a small portion depicted as PFO1C & PFO1/4Bd (palustrine wetlands). USGS Topographic Maps depict the site as partially developed. The site is approximately 4000 linear feet from the nearest WOUS (Atlantic Ocean).

Located onsite are two upland excavated non-jurisdictional ponds and seven upland excavated non-jurisdictional ditches that serves as part of the storm water system for the surrounding area.
