approximately 0.22 acres and Non-jurisdictional Pond B is approximately 0.13 acres. They were both dug from uplands and actively receive stormwater from adjacent uplands. Pond A is located on a golf course. Pond B receives stormwater from a couple non-jurisdictional linear conveyances. Both ponds are open water ponds with vegetation around the edges of them. Neither pond meets the three parameters to be considered wetlands. For these reasons, the stormwater ponds were determined to be non-jurisdictional and not regulated by section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
