Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This Basis form covers the pRPW, Tributary A which is directly abutted by Wetlands D, F, G, H and J. The wetlands total 8.19 acres of waters of the U.S. Wetlands that directly abut pRPWs that empty into TNWs are by definition jurisdictional. Therefore the wetlands were determined to be jurisdictional and subject to regulation under Section 404 of the Clean Water Act. Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is an approximately 118.53 acre site. The project area is drained by two pRPWs that each flow into the Ashley River, a TNW. This Basis form covers the offsite pRPW which is directly abutted by Wetlands A, B, C, E and I. The wetlands total 52.96 acres of waters of the U.S. Wetlands that directly abut pRPWs that empty into TNWs are by definition jurisdictional. Therefore the wetlands were determined to be jurisdictional and subject to regulation under Section 404 of the Clean Water Act. The jurisdictional status of the remaining wetlands is discussed in form 1 of 2.
