Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The project area contains numerous upland excavated ditches that only drain uplands and remove storm water from the site. The site was previously managed for timber and the majority of the non-jurisdictional ditches that exist were constructed for the removal of surface for the establishment of Loblolly Pine. In addition, the site contained several areas that were inspected for freshwater wetlands: however, these areas lacked all three of the parameters outline in the Corps' 1987 Wetland Delineation Manual specifically lacking the Hydrology parameter. The site visit was performed under normal climatic conditions.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is comprised of 414 acres. Of which, all with the exception of the area where the onsite tributary is located was determined to be uplands. Potential wetlands and onsite drainage features were assessed during the site visit of November 9, 2016. Potential wetland areas assessed did not contain all three parameters that define a wetland. In addition onsite drainage features were assessed on the site visit of 11/9/2016. With the exception of the tributary (Black Creek) located within the eastern portion of the project area, all other features (ditches) were determined to be non-jurisdictional upland excavated drainage features. The site visit was performed under normal climatic conditions.
