This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 1.078 acre tract that was determined to consist entirely of uplands. The USGS topographic information within Dillon West Quad depicts the project area as cleared uplands that do not contain any blue line features or other symbols that would typically represent a WOUS. Dillon County Soil Survey information depicts the project area as being comprised entirely of Faceville loamy fine sand, which is described as a well-drained non-hydric soil. NWIs depict the project area entirely as upland agricultural cropland/pasture and aerial photographs depict the project area as an existing upland agricultural field. In addition, an approved JD was issued on July 23, 2010 in which the Corp determined that the project area was void of any aquatic resources. A site visit was conducted on July 12, 2010, in association with the before mentioned JD at which time it was documented that the site lacked all three parameters of wetland criteria and that the sites geomorphic position has it located near the crest of a hill where its elevation is higher than the surrounding area. At the time of the site visit, the field was fallow with no hyrdophytic vegetation present.
