entering the wetland. It is approximately 1,000 feet from the nearest off-site water of the U.S. The wetland is located close to the property boundary. Any possible off-site features are located uphill from the wetland and would be flowing into the wetland. There are no signs of drainage features, shallow subsurface flow or overland flow off-site or to other waters on-site. This isolated wetland shows no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. 
