linear features on site were constructed to drain upland agricultural fields. The NWIs map this entire site as upland agricultural fields (U21), and the soil survey maps the majority of this site as Goldsboro, which is partially hydric, and Noboco, which is not hydric. Small areas on site are mapped Coxville and Rains, which are hydric soils; however, this site has been in active ag. production since prior to 1994, according to the aerials. Therefore, these linear features were determined to be non-jurisdictional ditches.



# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
