Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A borrow pit was observed in the field on December 9, 2015. The pit was determined to be excavated entirely out of uplands. The landowner stated that the pit was excavated for road construction when the subdivision was developed. The pit is completely surrounded by non-hydric soils. As stated in the Preamble to the November 13, 1986,

Regulations found on page 41217, "waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United States". For these reasons, this borrow pit was determined to be non-jurisdictional and not regulated by Section 404 of the CWA.

#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site consists entirely of uplands. All soils throughout the site were determined to be non-hydric. The soils had high chromas and did not match any of the hydric soil indicators (please see data sheets in file for details). In addition, there was no evidence of hydrology. Hydrology (i.e. water) was observed in the onsite borrow pit. However, the pit was excavated entirely out of uplands for the purpose of utilizing the material to construct the roads within the subdivision. The pit was completely surrounded by non-hydric soils and was determined to be non-jurisdictional. One site visit was performed.
