**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This site consists entirely of uplands. A desktop review was performed for this site. According to the best available information (i.e. aerial photography, topographic maps, NWI maps, soil survey information), the site does not contain any jurisdictional wetlands or other waters of the U.S. According to the information mentioned above, the project area is comprised of Nansemond (non-hydric) soils, is listed as U21 (upland) on NWI maps, and there are no aquatic resources depicted on topographic maps within the project boundaries. In addition, the consultant submitted data sheets and pictures of the site further supporting the Corps' determination that the site is comprised entirely of uplands..
