the southeastern property boundary of the site and is depicted as a blue line on the topographic map. During the site visit, this feature was observed as originating near the southern property boundary and no longer continues southwest toward Shot Pouch Branch. This feature continues northeast where it intersects with the jurisdictional tributary located along the northeastern property boundary. This feature was observed as having no OHWM and had dry leaf litter and debris present in the bottom. No other indicators of flow were observed. This linear feature was previously determined to be a non-jurisdictional ditch in file no. SAC 2006-02051 (Letter dated March 3, 2008). Based on this information, this feature was determined to be a non-jurisdictional ditch.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

perennial flow based on a review of the aerials, topographic map, soil survey, and information obtained during the site visit. The aerials and topographic map depict this feature as a shaded linear feature and a solid blue line, respectively. The soil survey maps this tributary as Rains, a hydric soil. This linear feature was observed during the site visit and had flowing water and an OHWM present. Other indicators of flow observed include a firm sandy bottom and a lack of vegetation in the channel. This tributary continues southeast where it flows into Shot Pouch Branch, a perennial RPW. Shot Pouch Branch flows south into Green Swamp, a perennial RPW, which flows southeast into the Pocatoligo River, a perennial RPW. The Pocatoligo River continues southeast into the Black River, a TNW.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** A potentially jurisdictional linear feature was assessed within the review area. This feature is located along the southeastern property boundary of the site and is depicted as a blue line on the topographic map. During the site visit, this feature was observed as originating near the southern property boundary and no longer continues southwest toward Shot Pouch Branch. This feature continues northeast where it intersects with the jurisdictional tributary located along the northeastern property boundary. This feature was observed as having no OHWM and had dry leaf litter and debris present in the bottom. No other indicators of flow were observed.. This linear feature was previously determined to be a non-jurisdictional ditch in file no. SAC 2006-02051 (Letter dated March 3, 2008). Based on this information, this feature was determined to be a non-jurisdictional ditch.

The tributary located along the northeastern property boundary was determined to have perennial flow based on a review of the aerials, topographic map, soil survey, and information obtained during the site visit. The aerials and topographic map depict this feature as a shaded linear feature and a solid blue line, respectively. The soil survey maps this tributary as Rains, a hydric soil. This linear feature was observed during the site visit and had flowing water and an OHWM present. Other indicators of flow observed include a firm sandy bottom and a lack of vegetation in the channel. This tributary continues southeast where it flows into Shot Pouch Branch, a perennial RPW. Shot Pouch Branch flows south into Green Swamp, a perennial RPW, which flows southeast into the Pocotaligo River, a perennial RPW. The Pocotaligo River continues southeast into the Black River, a TNW.
