

## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland limits established by the 1987 Wetland Delineation Manual. Wetlands were determined to be adjacent, directly abutting, the offsite tributary by review of aerial photos, Horry County Soil Surveys and Horry NWI maps. Aerial photos depict a signature of wetlands directly abutting tributary; tributary flows through wetlands an dishcarges directly into the Waccamaw River. Horry NWI depicts wetlands as directly abutting with a NWI classification as PFO1B, Forested wetlands contiguous to offsite tributary. Horry County Soil Survey depicts the soil type of wetlands (both onsite and offsite) as Bladen and being contiguous to the offsite tributary. Bladen is a listed hydric soil on the National Hydric Soil ListWetland is part of a larger, offsite wetland complex that is eventually bisected by the OHWM of a unammed perennial RPW that discharges into the Waccamaw River.
