Horry County Soil Survey, NWI, LIDAR data, no surface or shallow subsurface connection to another water of the U.S. was evident. All water contained within the wetlands is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, surrounding infrastructure, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps depict no wetland symbols where the isolated wetlands were observed in the field. No linear features (i.e. blue lines) were observed in the field or depicted on the topographic maps in the vicinity of the isolated wetlands. Additionally, a 0.31 acre upland excavated non-jurisdictional pond is located onsite with no connection to WOUS.

C. SIGNIFICANT NEXUS DETERMINATION
