#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

RPW by an Approved Jurisdictional determination, SAC-2015-00014, issued on March 3, 2015. At the time of the previous site visit, the RPW had flowing water, displayed an OHW mark, had a channel mostly void of vegetation and the vegetation present was the obligate plant *Alternanthera philoxoides*. In addition, the channel is visible in aerial photography and appears as a solid blue-line stream on the topo maps. The RPW continues west and crosses Sam Rittenburg Boulevard, Orleans Road, and I-526 where it discharges into an unnamed tidal creek of the Stono River. The RPW was inspected at these public road crossings and flowing water was observed. For these reasons, this RPW was determined to have perennial flow and is therefore jurisdictional and regulated under Section 404 of the CWA.
