only conveys storm-water sheet-flow and groundwater recharge from rainfall events. This ditch was excavated out of uplands to provide soil drainage for agricultural operations, a common practice in South Carolina farm fields. This ditch is considered non-jurisdictional per the Corps authority.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This 63 acre site is identifiable as a managed agricultural field, with aerial imagery, geographic location, and site photos. The majority of the site is cleared uplands used for farming activities.

The applicant's environmental consultant, Pilot Environmental, Inc., provided one data point within a depression area of possible palustrine wetlands on the northern portion of the site (Lat: 34.3046, Long: -79.9205) and hydric soil and wetland hydrology was not found at that point.

On-site is one linear excavated drainage ditch of 1,130 linear feet, this ditch drains into an off-site pond and only conveys storm-water sheet-flow and groundwater recharge from rainfall events. This ditch was excavated out of uplands to provide soil drainage for agricultural operations, a common practice in South Carolina farm fields. This ditch is considered non-jurisdictional per the Corps authority.

Darlington West quadrangle USGS map. This map depicts a mostly non-forested site bounded to the north by the off-site Swift Creek and its adjacent wetlands. The northern project boundary captures a small region of non-wetland forested land on the edge of the elevation decline associated with the banks of Swift Creek, depicted by green cross-checked shading within brown contour lines. Additionally, the map depicts two linear aquatic features depicted as a solid blue line broken by dashes; only a portion of one of these features is currently present within the site. The present feature correlates to an on-site non-jurisdictional excavated ditch running through the middle of the site for the purpose of storm-water drainage.

The Darlington County Soil Survey, page 32, depicts four on-site soils. Two of the soils are listed as hydric per the 2016 South Carolina Hydric Soil list, including Rains sandy loam (0-2% slopes) and Bonneau sand (0-6% slopes); these soils are within areas of possible inundation, located adjacent of the excavated drainage ditch and the forested area in the northern portion of the site. The other soils, Noboco loamy sand (0-2% slopes) and Norfolk loamy sand (0-2% slopes) are not listed on the hydric soil list and are found within the heavily managed and altered (agricultural field) sections of the project site.

National wetland inventory (NWI) maps depict the site as mostly upland planted pine (U42P) (60.35 acres). Within the forested area inside of the northern project boundary is a 2.25 acre region of evergreen upland forest, and a 0.40 acre area of palustrine broad-leaved forested seasonally saturated wetlands.

On January 11, 2018, the Corps performed a site visit to verify the presence, location, and jurisdiction of any on-site resources. While on site no jurisdictional resources were found.

This site was assessed on a single basis form per the provided location maps.
