- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Located within the southeast portion of the site is a ~0.05 acre abandoned excavated barrow pit that is now mostly filled. Due to this feature being depressional in nature it was assessed by the applicant's consultant, SM&E, for wetland criteria. Hydrophytic vegetation was found within the pit, but neither hydric soil criteria nor wetland hydrology were present at the time of assessment. Furthermore, these findings were validated by Corps personnel during a January 14, 2019, site visit.

Summarize rationale supporting determination: Collins Creek is a tidally influenced tributary of the Waccamaw River (TNW) which drains into the Waccamaw River at river mile (RM) ~23. The Waccamaw River is tidally influenced to RM 60 and is navigable to RM 140, well north of the project location. Collins Creek supports a wide swath of wetlands on either side of its banks throughout its reach, year-round. Furthermore, Collins Creek has a well-defined bed and bank visible on USGS topographic maps, LiDAR aeriels, and aerial photographs. All indicators depict Collins Creek as a tributary with flowing water at least 90% of the year under normal climatic conditions. Given all of the above information the Corps have determined the portion of Collins Creek within the project area to have a flow regime of perennial and it to be classified as a traditionally navigable water.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": On-site are 9.03 acres of wetlands meeting the 1987 delineation manual three-criterion wetland classification, these wetlands directly intersect the MHW line of the eastern bank of Collins Creek.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

This sites western project boundary directly abuts 1630 linear feet of Collins Creek (TNW) and its directly abutting 9.03 acres of wetlands. Collins Creek is a tidally influenced tributary of the Waccamaw River (TNW) which drains into the Waccamaw River at river mile (RM) ~23. The Waccamaw River is tidally influenced to RM 60 and is navigable to RM 140, well north of the project location. Collins Creek supports a wide swath of wetlands on either side of its banks throughout its reach, year-round. Furthermore, Collins Creek has a well-defined bed and bank visible on USGS topographic maps, LiDAR aerials, and aerial photographs. All indicators depict Collins Creek as a tributary with flowing water at least 90% of the year under normal climatic conditions. Given all of the above information the Corps have determined the portion of Collins Creek within the project area to have a flow regime of perennial and it to be classified as a traditionally navigable water. Additionally, on-site are 9.03 acres of wetlands meeting the 1987 delineation manual three-criterion wetland classification, these wetlands directly intersect the OHWM of the eastern bank of Collins Creek. The presence, location, and jurisdiction of on-site aquatic resources was validated by Corps personnel during a January 14, 2019, site visit.

Brookgreen Quadrangle USGS topographic map depicts a forested site bounded to the east by Old Journeys End Road (known as Old Murrells Inlet Road) and to west by Collins Creek and its adjacent wetlands, illustrated by a solid blue line and wetland symbols.

Horry County Soil Survey, sheet 91, depicts three soil types within the project area, including: Meggett loam, Yauhannah fine sandy loam (0-2% slopes), and Kenansville fine sand (0-6% slopes). Megett Loam is depicted along the western edge of the project site, within and adjacent to Collins Creek. Yauhannah loam is depicted in the southeast portion of the site in an area that was historically used as a barrow pit. Kenansville fine sand is depicted over the remainder of the site. Meggett loam and Yauhannah fine sandy loam are both listed as hydric soils on the 2016 South Carolina hydric soil list.

Located within the southeast portion of the site is a ~0.05 acre abandoned excavated barrow pit that is now mostly filled. Due to this feature being depressional in nature it was assessed by the applicant's consultant, SM&E, for wetland criteria. Hydrophytic vegetation was found within the pit, but neither hydric soil criteria nor wetland hydrology were present at the time of assessment. Furthermore, these findings were validated by Corps personnel during a January 14, 2019, site visit.

On-site are 9.03 acres of jurisdictional wetlands and 1630 x 15 feet of a TNW meeting the requirements of a jurisdictional water of the United States.

This 24.45 acre site was assessed per the provided maps and on a single basis form.
